



MOBILE FOOD UNITS

Mobile Food Units, including food trucks, carts, and pushcarts, can be permitted within the City of Tualatin as regulated by Tualatin Municipal Code 9-10. Certain activities are exempt from obtaining a Mobile Food Unit Permit, such as, private catering events where the sale or distribution of food is not open to the public. A full list of exemptions can be found in TMC 9-10-010(2).

GENERAL REQUIREMENTS

- Only one mobile food unit per site at a time
- Must be parked on a paved surface and not interfere with the safe passage of vehicles, bikes, and pedestrians
- Must be in a zone that allows a mobile food unit or pushcart as applicable (see chart below):

	Must be designed to be pushed or pulled by a person

SUBMITTAL REQUIREMENTS

- Mobile Food Unit Application Form
- Property owner signature or consent letter
- Fee
- Proof of health and sanitary license
- Proof of City of Tualatin business license
- For pushcarts proposed within 200 feet of a restaurant or fruit and vegetable market, include letter of consent from all business owner(s)
- Site plan showing:
 - A scaled site plan or aerial map of the entire property where the food unit will be located
 - Where the food unit will be located on the site (must be on a paved surface)
 - Nearby pedestrian pathways, driveways, and property lines
