- Property owner authorization via signed application form or letter of authorization
- Elevations drawn to scale with sign, wall, and building dimensions
- Site plan drawn to scale with north arrow and sign location (for freestanding signs, include dimensions from property line along public rights-of-way)
- Identify any existing signs on the subject property and include their dimensions and square footage
- Application fees

- Please refer to Chapter 38 of the Tualatin Development Code (TDC) for information regarding sign standards.
